

Privacy Policy for [PteroCA.com](https://pteroqa.com)

1. General Information

1. This Privacy Policy describes how the website <https://pteroqa.com> (“Website”) collects and processes technical information.
2. The Website is operated by **Frostbyte Digital LLC**, a limited liability company organized under the laws of the State of Wyoming, USA (“Administrator”).
3. The Website serves informational and documentation purposes only. It does not provide user registration and does not directly collect personal data such as names, emails, or account credentials.

2. Collected Information

1. The Website may automatically process technical information such as:
 - browser type and device information, operating system version,
 - time of access, HTTP requests and headers,
 - cookies required for security and performance (e.g., Cloudflare).
2. This information is primarily used for technical, statistical, and security purposes.
3. The Website itself does not directly collect personally identifiable information (PII) such as names or emails.

However, third-party services used by the Website (such as Cloudflare and Google Analytics) may temporarily process limited technical data, including IP addresses and cookies, for security and analytics purposes. This processing is carried out under their own privacy policies and within the scope of applicable data protection laws (including GDPR).

3. Anonymous Telemetry

1. The **PteroCA** installer may collect **anonymous technical data** (e.g., software version, OS family, install status).
2. No personal data, domain names, API keys, or IP addresses are collected.
3. Telemetry helps to improve reliability and development of the project.
4. Users can disable telemetry anytime using the `--no-stats` flag or panel settings.

4. Cookies

The Website uses cookies only for:

- security and caching (via Cloudflare),
- anonymous traffic analytics.

Users may disable cookies in their browser at any time.

5. Third-Party Services

The Website uses several external service providers to ensure performance, security, and community engagement:

- **Cloudflare, Inc.** – provides CDN services, caching, and security protection (including DDoS mitigation).
- **GitHub, Inc.** – hosts the project’s open-source code.
- **Discord, Inc.** – provides communication and support channels for the project’s community.
- **Google LLC (Google Analytics)** – provides anonymous traffic and usage analytics.

Each of these providers processes limited technical data (such as IP addresses or cookies) in accordance with their own privacy policies:

All communication uses HTTPS and is protected by security measures such as Cloudflare WAF.

Anonymous telemetry data may be stored up to **90 days**, and only aggregated data may be stored thereafter.
